SECTION 4: First aid measures

4.1. Description of first aid measures

General information

In all cases of doubt, or when symptoms persist, seek medical advice. In case of unconsciousness give nothing by mouth, place in recovery position and seek medical advice.

7.1. Precautions for safe handling

Advices on safe handling

Avoid contact with skin, eyes and clothes. Avoid respiration of swarf. When using do not eat, drink or smoke. Personal protection equipment: refer to section 8. 
